

Whānau Āwhina Plunket Virtual Fun Run – Terms and Conditions 2022

TERMS AND CONDITIONS

- 1. Participating in the Whānau Āwhina Plunket Virtual Fun Run is undertaken at the participants own risk.
- 2. The decision to participate in the Event is entirely my own and I accept all risks associated with my participation in the Event, including but not limited to, loss of life or permanent injury. Regardless of any decision made, or information made available, by Whānau Āwhina Plunket and other persons, corporations, and entities involved or engaged in promoting or staging the Event, I agree to accept full responsibility to inform myself and assess all the dangers, hazards and risks of entry in the Event and rely solely on my own assessment of these dangers, hazards and risks before participating in the Event. Covid-19 is an extremely contagious disease that can lead to severe illness, permanent disability and death. An inherent risk of exposure to Covid-19 exists in any public place where people are present despite precautions that are taken. I acknowledge that by visiting any Event related venue, I assume all risks related to the exposure of Covid-19

Weekly prizes

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
